2. Department for Transport Update	ACTIONS
Dan Taylor, Deputy Director, Regional Partnerships and Delivery, Regions, Cities and Devolution, Roads and Local Group,	
Dan provided the following summary on current DfT announcements, specifically Network North:	
<ul> <li>An additional commitment of £8.3billion has been announced for Roads (Highways Maintenance Fund). This will cover the next 10 years and be in addition to the current funding. No further details currently but DfT sponsors will keep TE updated.</li> </ul>	
• There are no further details on Network North, however DfT confirmed existing MRN and LLR road schemes will benefit from an uplift in government contributions from 85% to 100% from Outlined Business Case stage.	
<ul> <li>Future of Rural Strategy has been published on 2<sup>nd</sup> October, link here. TE has worked closely with DfT on this document, including a DfT Pledge to work closely with the TE Rural Centre of Excellence.</li> </ul>	
<ul> <li>The 'Plan for Drivers' was published on 2<sup>nd</sup> October. This includes a range of interventions, including funding for upgrades on travel signals and a universal parking app.</li> </ul>	
<ul> <li>LTP Guidance is still pending, and LTAs are asked to continue with current plans and await further information.</li> <li>Business Planning Guidance for STB Business Plans 2024/25 will be shared by COP 27<sup>th</sup> October from DfT.</li> </ul>	
Comments:	
<ul> <li>Even with the additional uplift from Gov, private funding would still be expected. Details requested from DfT on what CIL requirements will be.</li> </ul>	DfT to confirm CIL funding and the timeline of a decision from HM
<ul> <li>DfT is still waiting a decision from Treasury on the Army &amp; Navy Scheme.</li> </ul>	Treasury on Army & Navy.
<ul> <li>Views expressed that decisions still need quicker timelines; councils are running out of funding to keep schemes 'alive'.</li> </ul>	
<ul> <li>SCC / DfT / EDF conversations are taking place on Sizewell C and their contributions to A12 schemes.</li> </ul>	
<ul> <li>Three A47 schemes at Blofield, Easton and Thickthorn have been granted an appeal by the Court of Appeal.</li> </ul>	
3 Investment Programme and Funding Update	Actions
Andrew Summers, Chief Executive, Transport East updated members. Key points were:	



- The TE business plan for 23/24 was revised following funding confirmation from DfT over the summer. TE original grant allocation of £944k for 2023/24 was reduced and held at 22/23 levels, as for all STBs across England in light of the financial situation. TE Leadership Team and TESOG undertook a prioritisation exercise to match the work programme with the available budget, and this was approved by Forum members via email in September.
- The government's publication of 'Network North' including intention to proceed with a number of priorities that Transport East had previously provided advice to the Secretary of State on:
  - Ely and Haughley rail schemes
  - o Major Road Network Programme for the East
  - o The £2 bus fare scheme was extended until the end of December 2024.
- There was an agreement from members to continue to work with DfT, National Highways and Network Rail to ensure rapid delivery of strategic projects.

Esme Yuill provided the below paper on the recent National Infrastructure Assessment that was published on 18<sup>th</sup> October.



There are several positive recommendations that, if taken forward, would benefit transport in the East. These include:

- New five-year transport budgets for all county councils and unitary authorities by the end of 2025 sufficient to
  cover maintenance, renewals and small to medium enhancements. We, and our partners, have consistently made
  the case to government that our local authorities need greater certainty and flexibility of funding for transport
  networks.
- Government should support £8 billion a year of investment in local transport outside London. This represents a 20 per cent increase on current spending levels.
- Government should complete East West Rail and a portfolio of targeted network enhancements across the country.
- Accelerating the deployment of electric vehicle public charge points. This is in line with Transport East's recent
  analysis of provision in the East which identified 15,000 new chargers would be needed by 2030 to meet forecast
  demand.



- Accelerating the transition to a decarbonised energy supply and investing in infrastructure to keep pace with increased demands to fuel transport in the future, both electricity and hydrogen.
- The report also recommends ongoing Government engagement with Sub-national Transport Bodies, including Transport East on transport infrastructure requirements and investment, including through the development of an Integrated Transport Strategy

The discussion also noted that the transport connectivity analysis was sparse for the East, and Officers are following up with the NIC to understand in more detail how the analysis was taken.

### Comments and discussion

- We need a compelling visual representation (potentially infographic) of the East, showing our priority schemes, our key economic USPs, and how the East benefits the rest of the country. A visual aid that can be shared widely is of high importance.
- Ely needs to be 'billed' as a Road and Rail improvement scheme, not just a rail scheme.
- It was noted that the A47 and A12 from RIS2 were not mentioned in the Network North report, nor are the RIS3 Pipeline schemes.

### 4 Strategy Hub Report and Presentation: Rural Mobility

Dr Scott Copsey, Smart Mobility Research Unit Director and Esme Yuill, Head of External Affairs gave a presentation on the completed Strategy Regional Hub – Call for Evidence Rural Mobility (slides below)

### 5 Rail Plan for the East Update

TE to take forward and develop the infographic.



Andrew Summers, Transport East & Sarah Jane Crawford, Principal Programme Sponsor, Anglia Route, NR provided an update on recent activity. (Slides below)



- Transport East is currently undertaking several pieces of work that will complete in spring 24 on rail, these include.
  - Quick Wins priorities for the next 5 years
  - Regional Connectivity Study
- Cllr Alexander Nicoll, Chair of EWR Eastern Section, was voted to be joint Vice Chair of the EWR Mainline Partnership Board at their last meeting.
- Cambridge South and Beaulieu Park are on schedule for delivery in Spring and Summer 25.
- Cambridge area has secured a further £200 million for resignalling.
- NR are supportive of the creation of the Essex Thameside Task force and working with TE and partners in the Rail leadership group to progress this.
- Liverpool Street pedestrian improvement programme is progressing well.
- Iterative changes at Stratford Station are under way and will continue over the next 4 years. Stratford Station does have further development with aspirations with the London legacy Development Corporation and other government departments.
- NR have engaged with government and made clear that NR are ready to 'go' on the Ely upgrade. The scheme was closed in way that allows for a quick enablement; however, the scheme is large, and it will take three to six months to get all the appropriate contracts in place and ready for the next stage.

### **Comments and discussion**

- The news on Ely and Haughley is encouraging but still significant amount of work and approvals required to deliver the schemes.
- NR currently does not have a target start and end date. NR confirmed the next stage is 18 months and that will
  take us to design to establish delivery. Improvements can be delivered as part of maintenance programmes but
  as, yet nothing is decided.
- NR is urged to include within its procurement local values and establish robust supply chains that benefits the business communities across the region.
