The range of powers and funding available in the new Devolution Framework would support local policy priorities e.g., transport infrastructure, economic development, skills, environment and health improvement. And allow greater integration of policy making to achieve enhanced outcomes. The Mayor and MCCA bring enhanced profile and influence nationally for local benefit and facilitates work with local partners to deliver those benefits. Boundaries make geographic sense with Greater Essex having worked together on transport issues through Transport East and historically on economic growth and investment through the LEP. Evidence from established Mayoral devolved areas shows bringing powers closer to communities can increase the impact of both government and private sector investment. This is particularly seen with transport, where greater coordination and oversight can improve integration, better align with land-use and service planning and so increase positive social outcomes.

Rail & Freight pan-regional engagement structures exist and can facilitate Mayoral relationships with other regions to maximise impact

TE could support Mayors on Key Route Networks. TE already has identified core corridors and has strong engagement with National Highways.

TE has tools, analysis & data to inform MCCAs work and monitor against priorities. Existing evidence & procurement frameworks can be adapted to accelerate the work of any new Mayoralities.

The DfT has requested STBs to support strategic transport integration at a regional-level supporting the emerging Integrated National Transport Strategy.
